



Stacking

A micro-credential is approved as a standalone education product.

Micro-credentials can also be stacked into a programme leading to a qualification.





Legislation changes

We're reviewing the NZQA rules to reflect amendments to the Education and Training Act and to ensure the rules remain up-to-date and fit for purpose.



Skill standards

A skill standard specifies the skills, levels of performance and learning outcomes to be achieved. This is public information.

Skill standards are intended to be the **building blocks of vocational micro-credentials**, which all providers will use to support portability of learning and consistent graduate outcomes.

Qualifications and Credentials Framework

Heading: amended, on 1 August 2022, by section 24 of the Education and Training Amendment Act 2022 (2022 No 38).

436 Qualifications and Credentials Framework

- (1) The Qualifications and Credentials Framework—
 - (a) consists of all qualifications and micro-credentials that have been approved and listed by NZQA in accordance with the rules made under section 452; and
 - (b) includes the rules relating to the framework made under that section.
- (2) NZQA—
 - (a) must list on the Qualifications and Credentials Framework all qualifications and micro-credentials that it has approved in accordance with the rules made under section 452:
 - (b) may, in accordance with the rules, review, amend, remove, or alter the status of any qualification or microcredential on the framework.
- (3) If a qualification is removed from the Qualifications and Credentials Framework,—
 - (a) any programme approval granted to an institution under section 439 in respect of that qualification lapses; and
 - (b) any accreditation granted to an institution under section 441 in respect of that qualification lapses.
- (4) If a micro-credential is removed from the Qualifications and Credentials Framework,—
 - (a) any approval of the content of that micro-credential granted to an institution under section 445 lapses; and
 - (b) any accreditation granted to an institution under section 446A to provide that micro-credential lapses.

Similar to programme approval and accreditation rules.

Reviews

All existing micro-credentials will be reviewed to meet all the requirements of the Act and NZQA Rules, including:

- ✓ Content approval which includes the learning outcomes, structure (including standards) and assessment.
- ✓ Listed on the NZ Qualifications and Credentials Framework (NZQCF).
- ✓ A credit level of 5 to 40 credits (with scope for small variance).
- ✓ Support by Workforce Development Council(s) at Levels 1 to 6.

Micro-credentials that were Training Schemes

- Special reviews may take up to three years to complete.
- We will agree the timing with the relevant provider (developer).
- NZQA will work with the developer, stakeholders, WDCs, other regulators, and other interested providers.
- A sector-by-sector approach is preferred e.g. aviation, English language.
- Te Pūkenga is expected to review and rationalise its product offering.




Accreditation to deliver Micro-credentials

- Accreditation is based on an assessment of a NZQA registered provider's capability to deliver an education product.
- Any provider can apply for accreditation to deliver any listed micro-credential.

- The developer of the micro-credential would be consulted before any provider is granted accreditation to deliver it.
- Micro-credentials developed by WDCs and/or that consist primarily of skills standards are not "owned."
