- 2 Vagahau Niue refers to the authentic language of Niue as communicated in the Pacific island nation and in New Zealand.
- This unit standard is derived from the Learning Languages learning area, Communication, Language Knowledge, and Cultural Knowledge strands Curriculum Level 7 of *The New Zealand Curriculum*, Learning Media, Ministry of Education, 2007, and is related to the *Tau Hatakiaga ma e Vagahau Niue: The Niue Language Guidelines* (http://pasifika.tki.org.nz/Pasifika-languages/Vagahau-Niue) and the material in the *Teaching and Learning Guide for Languages*, Ministry of Education at http://seniorsecondary.tki.org.nz.

- 4 It is recommended that:
 - i the outcomes are assessed as part of an integrated unit of work, relevant to the learning context of the learner;
 - ii assessment be conducted in conjunction with assessment against other Vagahau Niue unit standards at this level.
- 5 Each spoken text for this unit standard:
 - i must be two minutes in length;
 - ii must be appropriate to the spoken manner or a text which is designed for oral delivery;
 - iii must be delivered in clear standard speech in a familiar accent;
 - iv may include distinct and differentiated voices, for example, female and male, vouthful and mature:
 - v may be heard as a whole, and in sections, with a pause after each section;
 - vi may be presented face to face, or in pre-recorded audio or audio-visual format. If audio-visual materials are used, these must not include large amounts of written text.

6 Definition

On familiar matters refers to regularly encountered information, ideas and opinions that will be expressed in Vagahau Niue, for example: sports (tau feua sipote), cultural (aga fakamotu), food (kai), family (magafaoa), church (tapu), community (maaga), traditions (mahani tuai), celebrations (tau fiafia), koli moe lologo (sing and dance), tau pulotu he tau mamatua (the wisdom of the elders), myths and legends, brochures, flyers, newspaper articles, social media, documentaries, short films.

Spoken manner refers to, voice modulation, voice projection, tone, pace, pause for dramatic effect, articulation, use of space, enunciation, stance, non-verbal cues.

Variety refers to texts selected from a range of different text types which have been created for different audiences and purposes.

Outcomes and performance criteria

Outcome 1

Demonstrate understanding of a variety of spoken Vagahau Niue texts on familiar matters.

Range

spoken texts that relate to familiar matters may include but not limited to – media extracts or reports on topics of personal and/or community interest, conversations, narrated extracts from short stories, public address announcements, sports commentary;

a minimum of three different text types is required.

Performance criteria

1.1 A response to each text is given in either English, te reo Māori and/or Vagahau Niue that shows understanding by making meaning of the information, ideas and opinions in the texts.

Range a response may include but is not limited to – clarifying

information, ideas and/or opinions; summarising information, annotating, amending, producing, or completing visual representations of ideas e.g., maps, sketches, diagrams.
