## Appendix

### Schedule of Fees for Commercial Use of NCEA and Scholarship Examination Material

These fees are for each standard. They cover commercial use for all parts of the exam, including resource material and assessment schedules or marking schemes.

The fee is the maximum NZQA will charge per standard. If you only use part of a standard, the fee may be lower.

#### Digital format fee

If you request the exam material in a digital format, we charge a processing fee:

- \$30 (excluding GST)
- \$34.50 (including GST)

#### Fees per standard

For commercial use of all the following standards, the fee is \$100 (excluding GST) or \$115 (including GST):

- New Zealand Curriculum – all achievement standards
- Te Marautanga o Aotearoa – all achievement standards
- Literacy and Numeracy and Te Reo Matatini me te Pāngarau – all standards, per event per week
