Education Report: NZQA's final 2023/24 Statement of Performance Expectations (SPE) for publication

Executive Summary

1. You were provided with a copy of NZQA's near final 2023/24 *Statement of Performance Expectations (SPE)* on 28 April 2023.
2. In your response to the Board Chair, you highlighted the good progress that is being made in strengthening and redesigning measures to improve measurability and expanding the framework to include impact measures, and the direction that is being taken with the SPE is the right one.
3. With this feedback, as per s149I(2)(c) of the Crown Entities Act 2004, NZQA is providing you with the final 2023/2024 SPE to present to the House of Representatives.
4. To meet the obligation to publish the document 'as soon as practicable' under 149L(1) in the Crown Entities Act 2004, NZQA will publish the document on the NZQA website by 30 June 2023.
