## Aide-Memoire: Unit standard use in NCEAs – supplementary information

## **Purpose**

- 1. This aide memoire is to provide you with supplementary information, following our recent discussion with you about the aide memoire 'Unit standard use in NCEAs' (OC00781 refers).
- 2. NZQA proposes to proactively release this briefing as part of the next publication of documents.

## **Discussion**

3. There were two follow up questions in relation to our discussion on 'Unit standard use in NCEAs'. The first was a request for more information about the number of credits from unit standards used, for the sub-group of students who used unit standards to achieve the minimum credit requirements for their NCEA (OC00781, paragraph 38 refers). The second was a request for more information about the New Zealand Certificates in Foundation Skills Levels 1 and 2 (OC00781, paragraphs 45 to 48 refer). The supplementary information requested is provided below.

Using unit standards to achieve the minimum credit requirements for an NCEA

4. In OC00781 we provided you with the proportion of students who used credits from unit standards to achieve the minimum credit requirements for their NCEA, at the typical year level, in 2023. We noted that in 2023, 36% of Year 12 NCEA Level 2 achievers used Level 2 or above unit standards to achieve their NCEA Level 2, and 31% of Year 13 NCEA Level 3 achievers used Level 3 or above unit standards to achieve their NCEA Level 3.

- 5. You requested additional information about the number of unit standard credits the 15,977 Year 12 NCEA Level 2 Achievers and the 9,788 Year 13 Level 3 Achievers needed to meet the minimum credit requirements of their NCEAs.
- 6. The minimum Level 2 credits required to achieve NCEA Level 2 is 60 Level 2 or above credits. For context in 2023, the average number of Level 2 credits Year 12 students who achieved NCEA Level 2 had was 102.

- 7. The minimum Level 3 credits required to achieve NCEA Level 3 is 60 Level 3 or above credits. For context in 2023, the average number of Level 3 credits Year 13 students who achieved NCEA Level 3 had was 90.
- 8. Table 2 below provides a frequency table, by bands of 5 credits each, of the unit standard credits required to meet the 60 Level 2 credit requirement for the 15,977 Year 12 Level 2 students. 20% of these students needed fewer than 10 credits from unit standards to achieve the minimum Level 2 credit requirements for NCEA Level 2.

9. On average, these 15,977 Year 12 students achieved 31 Level 2 or Level 3 credits from achievement standards.

10. Table 3 below provides a frequency table by bands of 5 credits each, of the unit standard credits required to meet the 60 Level 3 credit requirement for the 9,788 Year 13 Level 3 students. 31% of these students needed fewer than 10 credits from unit standards to achieve the minimum Level 3 credit requirements for NCEA Level 3.

- 11. On average, these 9,788 Year 13 students achieved 34 Level 3 credits from achievement standards.
- 12. Our previous aide memoire (OC00781, paragraph 28 and Appendix 1 refers) provides detail about the unit standards in which senior secondary students are being assessed. Information about the proportion of unit standard assessments occurring in schools or in another context (e.g. workforce development council, private provider, polytechnic, wananga, employer) is provided in paragraph 31 (again in OC00781).

New Zealand Certificates in Foundation Skills (Levels 1 and 2)

- 13. In OC00781, we provided you with information about the New Zealand Certificates in Foundation Skills (Levels 1 and 2). We noted that in 2023, 181 senior secondary students achieved the Level 1 certificate, and 65 achieved the New Zealand Certificate in Foundation Skills (Level 2). You requested more detail about these qualifications.
- 14. NZQA is the qualifications developer.
- 15. The Level 1 certificate is a 60 credit qualification and 92 organisations have NZQA-approved programmes to deliver this qualification including 40 schools.

16. Table 4 below shows the Level 1 certificate outcomes and indicative credits.

- 17. The Level 2 certificate is also a 60 credit qualification and 60 organisations have NZQA-approved programmes to deliver this qualification.
- 18. Table 5 below shows the Level 2 certificate outcomes and indicative credits.
