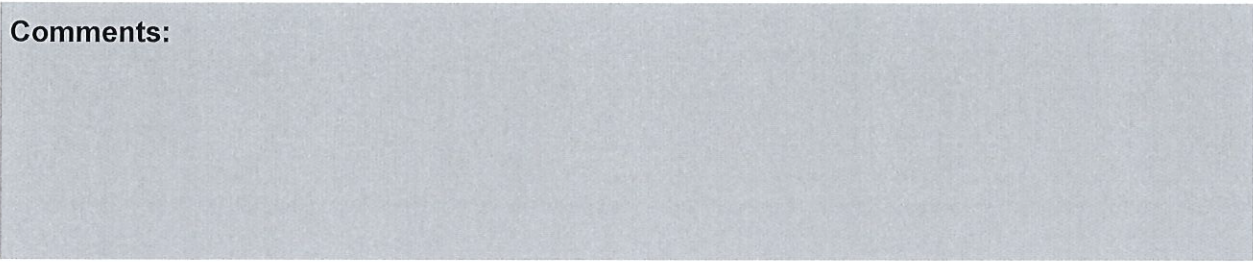

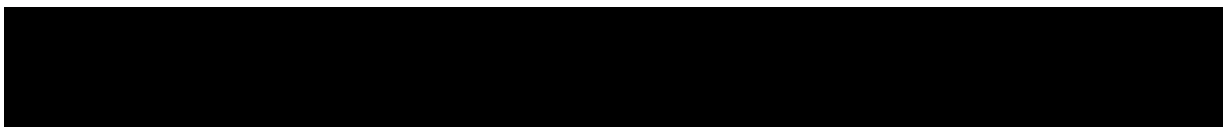
### Executive Summary
