Education Report: NZQA's final 2021/22 Statement of Performance Expectations (SPE) for publication

Purpose of Report

1. To provide you with printed copies of NZQA's final SPE to approve publication.

Background

- 2. You received NZQA's draft SPE on 3 May with a statutory timeframe to provide feedback within 15 working days.
- 3. The draft SPE documents were approved by you, without change, on 23 May 2021 in Education Report (CR22200 refers).
- 4. During the 15 days, the Ministry (the Ministry) of Education drafted and provided you with independent advice on NZQA's SPE. This has resulted in NZQA making the following minor changes to the SPE:
 - a. The addition of a narrative measure for the Codes of Practice for Pastoral Care
 - i. New Narrative measure: 2.2.2g Progress in embedding the code/s of practice for the pastoral care of international and domestic tertiary students and preparations for implementing the permanent Code from 1 January 2022.
 - ii. The new measure supports Impact Area 2.2 Qualifications are accepted as credible and robust nationally and internationally; and Intermediate Outcome 2.2.2 Quality assurance provides trust and confidence in NZ credentials and qualifications.
 - b. A minor figure transposition error was corrected in the Prospective Statement of Financial Position.
 - c. Three non-consequential text errors were corrected.
- 5. NZQA's final SPE is attached. NZQA will liaise with your office on timeframes for presenting the documents to Parliament.
- 6. To meet the requirements of the Crown Entities Act, NZQA will publish the SPE via its website as soon as practicable once it has been approved by you.
- 7. NZQA recommends that this report is proactively released, once the final SPE has been published.
