## Official Information Act (OIA) Request

Thank you for your request of 6 June 2018, under the Official Information Act 1982 ('the OIA'), for the following information:

"Please provide the following

- \* A list of tertiary education organisations that have closed since January 1, 2010 and their EER category (rating) at time of closure.
- \* A list of TEOs that have had their EER category downgraded since January 1, 2010 (include original rating and new rating).
- \* Copies of all the EER reports (or links to these reports) for the TEOs from the above two categories."

NZQA has interpreted your request as comprising three parts as set out below. The time-frame used to collate NZQA's response was from 1 January 2010 to 8 June 2018.

- (1) A list of private training establishments (PTEs) whose registration with NZQA has been cancelled or has lapsed between 1 January 2010 and 8 June 2018. Please note that tertiary education organisations (TEOs) other than PTEs do not "register" with NZQA, they are recognised through other statutory provisions.
- (2) A list of TEOs who dropped in category rating following an External Evaluation and Review (EER) process together with their category rating immediately before and after that EER. Please note that other EERs may have been conducted for these TEOs.
- (3) Copies of all the EER reports (or links to these reports) for the TEOs listed on our response for part (1) and part (2) of your request.

Please find enclosed information which falls within the scope of parts (1) and (2) of your request.

Regarding our response to part (1), please note those PTEs without a category rating listed were deregistered with NZQA before an EER was conducted. NZQA commenced EERs in September 2009 and are conducted at least every 4 years.

There are three groupings for deregistration under the Education Act 1989 ('the Act') as follows:

- Voluntary Cancellation Cancellation under section 233D(1)(c). ("At the written request of the establishment").
- Involuntary cancellation Cancellation under any of the following sections of the Act: 233D, and 255 (7) other than 1)(d).
- Lapsed Registration Automatic lapse under section 234. The lapse provisions took effect on 30 August 2012.

Regarding our response to part (2), NZQA has provided contextual information regarding the EER process below.

- The EER process is part of NZQA's Evaluative Quality Assurance Framework (EQAF) for non-university TEOs and was introduced in 2009.
- EERs are one part of our integrated quality assurance processes. Our quality assurance system includes qualification and programme approvals processes, accreditation to deliver, consent to assess and training scheme approvals, Industry Training Organisations (ITOs) quality assurance, Code signatory status, risk management of complaints and issues of non-compliance, programme monitoring and the EER process. Together these form a robust quality assurance platform.
- Where NZQA finds any problems, either as a result of a concern raised or from our own monitoring activities, firm action is taken. This may include requiring improvement plans, or where matters are very serious, statutory intervention. In all cases where NZQA takes statutory action, students are always our first priority.
- The EER process evaluates and determines levels of confidence in the educational performance and capability in self-assessment of all non-university tertiary education organisations (TEOs). Engagement in periodic external evaluation and review is one of NZQA's policies. Each external evaluation and review provides an independent judgement of the educational performance and capability in self-assessment of all non-university TEOs. - The levels of confidence for each judgement are used to determine a four-step category rating for the TEO, ranging from Category 1 to Category 4 as shown on our website: <a href="https://www.nzqa.govt.nz/about-us/our-role/legislation/nzqa-rules/qa-rules/external-evaluation-rules-2016/statements-of-confidence-categorisation-frequency-incentives-sanctions/11/">https://www.nzqa.govt.nz/about-us/our-role/legislation/nzqa-rules/qa-rules/external-evaluation-rules-2016/statements-of-confidence-categorisation-frequency-incentives-sanctions/11/</a>

- EERs are initiated through an ongoing scheduling process and occur at least once every four years. Category 3 and 4 organisations have their next EER scheduled sooner (within 1-2 years and 6-12 months respectively). NZQA may also bring forward an EER at any time if there are concerns over the quality of education performance or delivery or non-compliance issues relating to the Act or the NZQA Rules. NZQA may also agree to a request for an earlier EER made by a TEO.
- Additional to part (2) of your request, NZQA has provided additional information that provides the current status of these providers to date.
- If you would like to discuss the EER process in more detail or have any questions about the information enclosed, please do not hesitate to contact us.

NZQA has scoped part (3) of your request for copies of all EER reports (or links to these reports) for all TEOs included on these lists and we note the following:

- For the TEOs on these lists currently registered with NZQA their current EER reports are available online on NZQA's website: <a href="http://www.nzqa.govt.nz/providers-partners/external-evaluation-and-review/eer-reports/">http://www.nzqa.govt.nz/providers-partners/external-evaluation-and-review/eer-reports/</a>
- There are approximately 500 TEOs on these lists, many with two or more EERs conducted since 1 January 2010. NZQA has estimated that there could be as many as 1000 reports or more, which are often substantial, covered by your request.
- The historical EER reports for the providers on these lists (apart from those currently on our website) will take NZQA a considerable amount of time on top of our day-to day operations to collate. As such this will take some time to complete as it will have to be balanced with day to day operations therefore we will undertake to release these reports in stages, in batches by alphabetical order.
- As such we would like to continue to work with you to source this information. If you would like any EER reports for specific providers first, can you please help us to further refine your request to identify to us those reports this could help us provide this information in a timelier manner. We look forward to you letting us know the TEOs on the lists that you are most interested in for the purposes of supplying the EER reports. Otherwise we will continue to proceed to release these reports to you in batches by alphabetical order.

As part of the commitment to open and transparent government, NZQA is proactively releasing responses to Official Information Act requests which are of public interest. NZQA will be publishing its response to your request on its website on 30 September 2018. Your name and contact details will be removed before publication.


