### Official Information Act (OIA) Request

Thank you for your request of 24 September 2018, under the Official Information Act 1982 ('the Act'), for the following information:

*List of Private Training Establishment (PTEs) that have:*

1. Closed; or
2. Have had their consent to deliver withdrawn for international students that have been enrolled in a level 5, 6 or 7 business management programs, in the past 10 years.

Please find attached two tables prepared by NZQA in response to your request.

NZQA has interpreted point one of your request as related to PTEs that were able to enrol international students who had their registration cancelled by NZQA.

NZQA has interpreted point two of your request as related to PTEs that were able to enrol international students and had their accreditation to deliver level 5, 6, and/or 7 business management programmes withdrawn by NZQA.

NZQA's record of statutory actions starts from 1 July 2012. Statutory actions include withdrawal of accreditation and cancellation of registration.

As such, NZQA's response incorporates data from 1 July 2012 up until 24 September 2018, the date of your request under the Act.

As part of the commitment to open and transparent government, NZQA is proactively releasing responses to Official Information Act requests which are of public interest. NZQA will be publishing its response to your request on its website in December 2018. Your name and contact details will be removed before publication.
