The statistical moderation summary for business and IT programme to reflect the % of inconsistent or the agree/disagreement judgement with NZQA. E.g. numbers or % of the education provider at 50%/60%/70%/80%/90% consistent with NZQA."

In 2016-2017 NZQA monitored a total of 73 Level 7 programmes; 57 of these programmes included moderation.

Attached are tables detailing statistical summaries of monitoring conducted for Level 7 Business and IT programmes in the 2016-2017 period.
