## Official Information Act Request

Thank you for your request of 4 February 2021, under the Official Information Act 1982, for the information as stated below:

- The number of Year 12 students who obtained a Premier Award in the 2020 New Zealand Scholarship Examinations.
- The number of Year 12 stodents who obtained an Outstanding Scholar Award in the 2020 New Zealand Scholarskie Examinations.
- The number of Year 12 students was obtained a Scholarship Award (i.e. the award which generally requires at least 3 scholarships) in the 2020 New Zealand Scholarship Examinations.
- The number of Year 12 students who obtained a Top Subject Scholar Award in the 2020
  New Zealand Scholarship Examinations.
- The number of Year 12 students who obtained a Single Subject Award or two Single Subject Awards in the 2020 New Zealand Scholarship Examinations.

For the avoidance of doubt, I am assuming that a Year 12 student getting, say, a Premier Award, wouldn't count towards the number of Year 12 students getting, say, an Outstanding Scholar Award. Please let me know if that is not the ease.

I attach the following spreadsheet which covers the requested information:

## Note that:

- your assumption is correct in that a Year 12 student receiving a Premier Award does not impact on the number of Year 12 students receiving an Outstanding Scholar Award.
   Premier Scholarships are awarded to the top 10 to 12 of all students sitting NZ Scholarship.
   Outstanding Scholarships are then awarded to the next 40-62 students, so there can be a minimum of 50 or a maximum of 72 awards.
- while it is possible for a Top Scholar Award winner to also receive a Single Subject Award (giving them a maximum of an additional \$500 or a Premier Award), no Year 12 Top Scholar Award winning students also received these in 2020.
- Results for aggregate awards must be achieved in a single calendar year;i.e. they cannot be accumulated across multiple years. - year 12 students are eligible to receive the monetary prize when they meet the requirements :i.e. they enrol in full-time tertiary study with an approved tertiary provider in New Zealand. If they return to school, then the monetary prize is deferred until they enter tertiary full-time study. If they enter Scholarship again in Year 13, their entitlements will be based on the better of the two sets of results.
