Official Information Act Request

Thank you for your request of 29 March 2021, under the Official Information Act 1982, for the following information:

I am wanting to know how many students achieved NCEA Levels 1, 2 and 3 in 2019 nationally.

I want this broken down into Not Achieved, Achieved, Merit and Excellence for every NCEA level. It can be percentages.

I am also wanting the same information, broken down the same way for 2020.

The reasons for this application are covered by section 4 a (i) and (ii) of Part 1 of the Act.

The requested statistics for the 2019 academic year are shown in the tables below. Note that these statistics are based on:

- Typical Year Level which indicates whether the given qualification/requirement is of a level that the given year level students would typically be attempting to attain.
- Cumulative counts students who attained this qualification/requirement by the end of the given academic year.
