The NZQA Risk Management team's investigation file [for ICNZ] which contains information and pertinent correspondence relating to the investigative activities. [This starts from the programme monitoring reports from other NZQA teams, which highlight serious issues with assessment practice in ICNZ's business programmes (levels, 5, 6 and 7)].

I attach a copy of the following information, accompanied by a table: The NZQA Risk Management team's investigation file which contains information and pertinent correspondence relating to NZQA's investigation of ICNZ for the period from October 2016 to September 2017.

Under section 9(2)(a) of the OIA, the following information has been withheld:

- names, other personal information, and contact details of students of ICNZ
- qualifications and curriculum vitae of teaching staff of ICNZ
- cell phone numbers for NZQA staff and ICNZ staff other than Chirag Solanki.

NZQA is not aware of any public interest considerations which would outweigh the decision to withhold this information under section 9 of the OIA.
