Some hard words are in **bold** and in blue. They are thicker and darker. We explain what these words mean.



 We want to make sure that disabled learners can take part in tertiary education. Tertiary education means learning after school.




3. We want to make sure disabled people can use our services.

NCEA is a school **qualification**. A qualification shows that a learner has passed their assessments.



We want to make NCEA assessments better for disabled learners by:

 using technology that makes it easier for disabled learners to do assessments



 making assessments in a way that is good for everyone, including disabled learners



 making it easier for learners to get the support they need to do assessments



 measuring how easy it is for disabled learners to do assessments.

Our action plan and tertiary

education



Tertiary education includes university and other places that teach people how to do a job.



We want to make tertiary education better for disabled learners by:

 checking that disabled people are supported while they learn



 telling tertiary education companies how to support disabled learners.

Our customers include learners and people who work at schools and tertiary education companies.

We want to make sure disabled customers can use our services. We will do this by:



 asking disabled learners how easy or hard it is to use our services, for example calling our contact centre



making sure our online services are
 accessible. Accessible means everyone
 can use the service.


Our action plan and our staff
