Summary of review and consultation process

The review occurred as a result of the mandatory review of the *Teacher Education* qualifications, part of the Targeted Review of Qualifications (TRoQ). These qualifications were submitted under the Mātauranga Māori Evaluative Quality Assurance (MMEQA) process.

The mandatory review involved extensive consultation with stakeholders working in the sector. Consultation included meetings to discuss the need to review the qualifications, and subsequent meetings took place in order to consider the proposed content of the qualifications.

The existing national qualifications have been replaced by New Zealand qualifications, as detailed below.

Transition

The last date for entry into programmes leading to the replaced qualification is 31 December 2016. The last date of assessment for the replaced qualification is 31 December 2018 when the qualification will be discontinued. From that date no results can be reported against the qualification.

However, there are substantial differences between the new and replaced qualification, and it is recommended that candidates complete the qualification in which they are enrolled.
