Before the Assessment

Schools and teaching staff must check the Assessment Specifications for specific assessment instructions for each standard. These may include whether and how resources may be provided, equipment, supervision, and further assessment conditions.

NZQA assessment tasks will be provided to schools digitally. They will be available for download in the school portal from term 3, week 1.

Instructions on how to download non-end of year assessment PDFs

NZQA school portal login

Candidates complete the task during normal lesson time (or the school-examinations) during a period determined by the teacher, and as stipulated in the Assessment Specifications for each standard. This is called the assessment period. It is NOT the expectation that normal class timetables are changed, yet this is at the discretion of the school.

Should a school print assessment tasks for candidates (optional), these must be kept securely until the assessment period begins. Teachers and Principal Nominees should refer to the Conditions of Assessment and the school's established process for managing external assessments.

Tasks may be shared electronically with candidates at the start of the assessment period but must be retained at school. Candidates are not allowed to share or discuss the tasks with anybody else, inside or outside school.

For Level 1 Mathematics 91946 stimulus material is provided to the candidates before the assessment period starts. This will be available from term 3, week 1 through the <u>School Portal</u>

and may be shared with the candidates between this point and the start of the assessment. For this standard the teacher is then permitted to unpack the stimulus material with the candidates in class. Candidates are allowed to bring the stimulus material with their own annotations into the assessment session.

During the Assessment

A summary of guidelines for respective standards are available in Appendix A.

Submitted external assessments are external summative assessments, so teachers must not provide templates, scaffolding for answers or feedback during the assessment period.

Unless explicitly stated in the Assessment Specifications or task, it is expected that candidates do not access the internet while they are completing their assessment.

Derived Grades are NOT available to candidates for these standards, and it is expected that schools will provide a fair opportunity for them to complete assessments if they are unavoidably absent during the assessment period.

Derived grades for new achievement standards

Conditions of Assessment

The use of chatbots, generative AI, paraphrasing tools, or other tools that can automatically generate content is not permitted and material generated by these tools should not be submitted as part of the candidate's work.

Authenticity

Teachers must closely supervise the process of evidence collection to ensure that candidates:

- do not copy from another person or source without appropriate acknowledgement
- do not receive guidance, scaffolding, instruction, assistance, or assessment conditions beyond what is specified as permissible in the Assessment Specifications.

Authenticity processes for externally assessed standards.

Where a teacher cannot verify that the assessment submitted is the authentic work of the candidate, they must notify NZQA of a possible Candidate Breach of External Assessment.

Breaches of external assessment rules

After the Assessment

Candidates submit their completed assessment files through the NZQA learner portal as soon as they have completed each assessment. The portal will open for submission from week 1 of term 3. Schools should not wait for the Submission Deadline of 30 October before work is submitted.

NZQA learner portal login

Student work must not be accessible to them after the end of the assessment period. A secure copy of student work, be it digital or physical, should be stored by the school until the end of the Review and Reconsiderations period in February the following year.

At the end of the assessment period teachers must check that all the correct files have been submitted, for every candidate, and confirm the Authenticity declaration in the digital submission tool. Appendix B outlines the permitted file types.

These subjects do not provide a task. The candidates work on their submission using the Assessment Specifications for Guidance.

- *1 Teachers are allowed to unpack the Assessment task with the students before they begin their reports.
- *2 Teachers must invigilate the assessment to enable them to complete the Authenticity declaration when the work is submitted.
- *3 Teachers' guidance is allowed as described in the Assessment Specifications. For example, assisting in the choice of a dance at the correct level before the assessment, sourcing materials etc.
- *4 Specific materials are allowed to be brought into the assessment, as set out in the Assessment Specifications.
- *5 Assessment materials (tasks, responses, resources etc) are not allowed to be accessed by candidates between lesson times during the assessment period. Assessment materials and responses are to be kept secure at school.
