My grandmother asked me to make a dessert for an upcoming family celebration. I chose locally grown feijoas because they were free and didn't need to be transported from another country. This made my feijoa tart sustainable. The skins were composted in the school's compost bin.	My grandmother asked me to make a dessert for an upcoming family celebration. I chose locally grown feijoas because they were free. This means I had money left in my budget to buy more expensive organic flour. Because they are locally grown, the feijoas also didn't need to be transported far, which cut down on the carbon footprint.	My grandmother asked me to make a dessert for an upcoming family celebration. I originally planned to make a strawberry tart because my grandmother loves strawberries, but when I researched them, I found out that strawberries require a lot of water and are out of season, so they would need to be imported from overseas. This increases the carbon footprint.
	I composted the feijoa skins at school. The compost is used to fertilise the school's kitchen garden. This is a good way to dispose of the skins and fruit waste, and makes sure the waste is useful.	My grandmother said she also loves feijoas, and I was able to get them for free from my neighbour, so I decided on a feijoa tart instead. Because I didn't need to buy the fruit, I could choose from different flour options and still be within budget. I chose to buy more expensive organic flour as my grandmother uses this when she can.
		I have also been exploring different ways of disposing of the feijoa skins. I looked at composting, pickling for eating with cheese, and educating people about the eating of the skins.
