Te Whakatakotoranga Aromatawai ā-waho

Ko te whakaputa hanga hangarau e ea ai i tētahi hiahia motuhake te whāinga matua o te aromatawai ā-waho nei.

Ka mātāmua rā te kounga kitea i tētahi hanga hangarau nā te ākonga anō i hanga. Ka āta whakaaturia kia mārama ai te kaimātakitaki i te kiritaki, ā, ko te tangata, ko te hunga rānei, māna te hanga.

- Ka whakatakoto kōrero e whakaatu ana i tōna mārama ki ngā hiahia o te kiritaki.
- Ka parahautia ngā mahi, ngā whakatau, aha atu rānei mā ngā mauhanga (ā-pepa, ā-matihiko, ā-ataata, mā tētahi atu mauhanga rānei) e kitea ai āna mahi.

He tauira ngā pātai e whai ake nei, hei akiaki i te ākonga ki te āta whakamārama mai i ngā āhuatanga o te hanga:

Te Pūrākau

- He aha te hanga?
- He ingoa tō te hanga?
- He aha te kaupapa o te hanga?
- He aha ngā rawa me ngā rauemi i whakamahia hei whakaputa hanga?
- He kōrero anō mō te hanga?

Te Pūkenga

- He aha ngā pūkenga matua i whakamahia e koe hei whakaputa hanga?

Te Panonitanga

- He aha ngā panonitanga i a koe e mahi ana hei whakapai ake te hanga?
- He aha i panoni ai?
- He aha te hua o ngā panonitanga?

Ngā taunakitanga

Te hanga hangarau:

Ka taea e te ākonga āna kōrero ā waha te tuku ā-kiriata mai rānei, āna tuhinga te tuku ā konae tuhituhi mai rānei hei whakamārama i tana hanga.

1. He kiriata (rānei):

- » He kiriata, he kōrero ā-waha e 2 meneti neke atu rānei te roa.
- » He konae kiriata tōna āhua - mp4 | mov | 5GB; te oro; te kiriata rānei.

2. He tuhinga (rānei):

- » He konae tuhituhi – PDF (5-20 whārangi); te toi; te tuhi; te matihiko; te whakaaturanga; te ripanga rānei.

Ko ngā whakaahua:

Ahako he kiriata, he konae tuhituhi rānei, ka tāpirihia e te ākonga ngā whakaahua e whai ake nei:

- E 4 (nui ake rānei) ngā whakaahua - ka kitea ā - muri, ā - mua, ā - runga, ā - raro hoki.
- Ka whakaatu hoki e kite ai i ngā wāhanga whai pūkenga, hei tauira: he hono whāriki, he tāpiki, he aukaha, aha atu aha atu.

Ngā Herenga Aromatawai ā-Waho

He mahi takitahi tēnei mahi me te whakatakoto taunakitanga mō te aromatawai ā-waho mā te ākonga.

Kia tutuki pai ai te Kete Manarua ā-matihiko nei:

- me whakaputa hei PDF;
- me noho te rahinga tuari ki raro i te 5GB e pai ai te tārewatanga o ngā mahi ki te Online Digital Submission Portal;
- me tika te whakaraupapatanga o ngā mahi;
- me tika te whakatakotoranga o ngā mahi (kia kaua e noho tītaha, e huripoki rānei);
- me tāmau te kiriata ki te tītohunga ata, otirā, kāore e whakaaetia ana te tukunga o te honongaitua i tōna kotahi.

Te Motuhēhē o ngā mahi o ngā ākonga

Me pēhea e mōhiotia ai te motuhēhē o ngā mahi a ngā ākonga? He tukanga, he taunakitanga me whai, e mōhiotia ai nā te ākonga ake āna mahi aromatawai ā-waho. Kia mataara ngā ākonga, ngā kaiako me te whānau hoki o te kura ki te motuhēhē o ngā mahi a ngā ākonga.

He māmā noa iho te tiki mahi a tangata kē, heoi, mā te mihi e whakaatu, e whakanui hoki i ngā tātanga me ngā puna awhina i puta ai ngā mahi a ngā ākonga.

Hei tauira:

- He rerenga kupu poto e tohu ana i te pūtakenga mai o tētahi kōrero;
- He rārangi tohutoro i te whārangi whakamutunga o ngā mahi;
- He mihi ki ngā puna āwhina, ki ngā puna kōrero;
- Ngā momo puna awhina, puna kōrero rānei:
 - » he kōrero ā-waha: he uiui i ngā kaumātua, i ngā pakeke, i ngā rangatira, i ngā mātanga rānei;
 - » ngā pukapuka i whakaputaina;
 - » ngā pukapuka kāore anō i whakaputaina;
 - » ngā wāhitau ipurangi, ngā honongaitua rānei.
