Te Whakatakotoranga Aromatawai ā-waho

E rua ngā ara hei whakatutuki i tēnei aromatawai – ko te Ara Taonga, ko te Ara Kai rānei. Kei tēnā, kei tēnā o ngā kaupapa taiao ā-iwi ōna taonga māori, kai māori rānei. He kōrero tuku iho, he rawa māori hoki e hāngai ana ki aua kaupapa taiao ā-iwi.

Te Pūtaiao me te Te Hangarau: Ko ngā ākonga e whai ana hoki i ngā paerewa paetae **92054** **Te whakamārama i te rawa hangarau, 92055** | **Te whakaputa hanga hangarau rānei, tēnā kōwhirihiā te Ara Tāonga**, ka whakahāngaihia ngā taunaki nei ki te hanga hangarau nā te ākonga anō i hanga.

He take tiaki taiao, arā he taonga māori, hei kai māori rānei kei te kōkirihiā e tētahi iwi:

Ko te aronga matua o te tūmahi nei, ko te whakatakoto taunakitanga me ōna whakamārama e pā ana ki ngā hononga i waenga i ngā kōrero tuku iho o tētahi kaupapa taiao ā-iwi i whiriwhiria e te ākonga me te rautaki ā-iwi hei whakarauora kia hoki anō ki tōna āhua o mua.

Ka hāngai ngā whakamārama ā te ākonga ki ngā mahi a ngā tūpuna e ora pai ai tētahi taonga māori rānei, tētahi kai māori rānei nā ngā atua i tākoha mai hei tiaki mā te tangata, waihoki ko ngā huarahi e hāpai ai i te mana o te iwi.

Ko te kaupapa taiao ā-iwi e whiriwhirihia ana e te ākonga ko tētahi kaupapa taonga māori rānei (*Hei tauira: huata, karu atua, taiaha, wharenuī, kākāhu mauku, pōhā, piupiu, waitae*), ko tētahi kaupapa kai māori rānei (*Hei tauira: kai kōhua, hāngi, tuna kauruki, tītī kōhua, pātiki parai, kao kūtai, rewena*) e āta kōkirihi ana e tētahi iwi.

He tauira e whai ake nei o ngā momo kōrero ā-iwi hei kōwhiri mā te ākonga;

- he mōteatea (*hei tauira: haka, oriori, ngeri, waiata tangi*);
- he pūrākau (*hei tauira: ngā atua, ngā tūpuna, ngā tupua*);
- he pepeha;
- he karakia;
- he toi māori (*hei tauira: whakairo, tukutuku, kōwhaiwai*);
- he whakapapa;
- he uiui (*kaumatua, whānau, mātanga*);
- he kōrero ā-iwi,
- he kerēme ki te Taraipiunara o Waitangi
- he rauemi ā-iwi
- he rauemi ā-marae

Ngā taunakitanga

Ka taea e te ākonga āna kōrero ā waha te tuku ā-kiriata mai rānei, āna tuhinga te tuku ā konae tuhituhi mai rānei.

1. He kiriata (rānei):

- » He kiriata, he kōrero ā-waha e 2 meneti neke atu rānei te roa.
- » He konae kiriata tōna āhua - **mp4 | mov | 5GB; te oro; te kiriata rānei.**

2. He tuhinga (rānei):

- » He tuhinga e 250 kupu neke atu rānei te roa.
- » He konae tuhituhi – **PDF (5-20 whārangi).**

Ngā Herenga Aromatawai ā-Waho

He mahi takitahi tēnei mahi me te whakatakoto taunakitanga mō te aromatawai ā-waho mā te ākonga.

Te Motuhēhē o ngā mahi o ngā ākonga

Me pēhea e mōhiotia ai te motuhēhē o ngā mahi a ngā ākonga? He tukanga, he taunakitanga me whai, e mōhiotia ai nā te ākonga ake āna mahi aromatawai ā-waho. Kia mataara ngā ākonga, ngā kaiako me te whānau hoki o te kura ki te motuhēhē o ngā mahi a ngā ākonga.

He māmā noa iho te tiki mahi a tangata kē, heoi, mā te mihi e whakaatu, e whakanui hoki i ngā tāngata me ngā puna awhina i puta ai ngā mahi a ngā ākonga.

Hei tauira:

- He rerenga kupu poto e tohu ana i te pūtakenga mai o tētahi kōrero;
- He rārangi tohutoro i te whārangi whakamutunga o ngā mahi;
- He mihi ki ngā puna āwhina, ki ngā puna kōrero;
- Ngā momo puna awhina, puna kōrero rānei:
 - » he kōrero ā-waha: he uiui i ngā kaumātua, i ngā pakeke, i ngā rangatira, i ngā mātanga rānei;
 - » ngā pukapuka i whakaputaina;
 - » ngā pukapuka kāore anō i whakaputaina;
 - » ngā wāhitau ipurangi, ngā honongaitua rānei.
