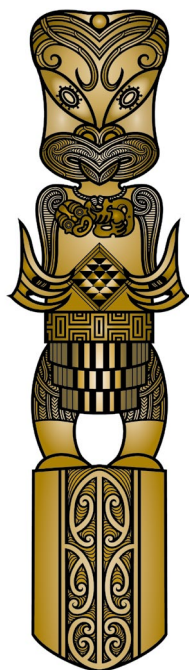

Te Whakatakotoranga Aromatawai ā-Waho

He kohinga mahi, he kohinga taunaki rānei nā te ākonga i whakaoti i te roanga ake o te tau hei whakatutuki i te whānuitanga o ngā Paearu Mahi me ngā Putanga ako. Mā konei e puta ai te ihu o te ākonga i tēnei Paerewa.

He Tūmahi Aromatawai e ārahi ana i te ākonga ki te whakatutuki i te whānuitanga o ngā Paearu mahi. Ka whakamahi te ākonga i te reo matatini kia tutuki ai te pūtakenga whakawhiti kōrero ā-waha, ā-tuhituhi hoki, ā, ka kōwhiria ngā rautaki matua, ka mārama ngā whakaaro matua, ka whakamahia ngā āhuatanga reo e hāngai ana ki te horopaki, ka mutu, ka tika te reo.

E rua ngā momo Tūmahi Aromatawai o tēnei Paerewa:

1. Te Tūmahi Tuhituhi

Ko tā te ākonga he whiriwhiri kaupapa hei mahi tuhituhi māna. Ka tuhia rānei he whakatairanga, he tuhinga taki rānei, he huritao rānei, he tuhinga auaha rānei, he aha atu rānei.

Ka **100–150** kupu te roa o te tuhinga a te ākonga.

2. Te Tūmahi Kōrero

Ko tā te ākonga he whiriwhiri kaupapa hei mahi kōrero māna. He kōrero ōpaki, he kōrero ōkawa rānei, ā, he kauwhau, he kōrero whakamārama (mō tētahi mōteatea rānei, mō tētahi taonga rānei, mō tētahi pūrākau rānei, mō te aha atu rānei), he kōrero auaha, he aha atu, he aha atu.

E āhei ana tā te ākonga whakakōrero i te kaupapa i tuhia rā e ia i te tūmahi tuhituhi, tāna whiriwhiri rānei i tētahi atu kaupapa hei kōrero māna.

Ka **1–2 meneti** te roa o te kōrero ā-waha a te ākonga.

Ka mau ā-hinengaro te ākonga i ngā kupu o ana kōrero, kia kaua ia e pānui i te tuhinga i a ia e kōrero ana, ka mutu, kia Māori te tū a te ākonga ki te kōrero ā-waha mai, ā-tinana mai hoki.

E whakaatu ana te Kete Manarua i tētahi tauira hei kōwhiringa mā te kaiako. Mā te kaiako tonu e whiriwhiri mēnā rānei ka whakamahia tētahi tauira, ka whakamahia rānei he mahi whakaharatau, ka whakaritea rānei he Tūmahi Aromatawai anō rānei.

Ko ngā Tūmahi Aromatawai i te Kete Manarua (tā te kaiako). He tauira hei kōwhiringa mā te kaiako, ka whakaritea rānei e te kaiako he Tūmahi Aromatawai kē. Tērā pea he rautaki aromatawai kē āna, hei tauira; he whakaaturanga, he whakamārama mō tētahi taonga, he mahi toi, he aha atu, he aha atu.

Ngā Herenga Aromatawai ā-Waho

He mahi takitahi tēnei mahi me te whakatakoto taunakitanga mō te aromatawai ā-waho mā te ākonga.

Te Motuhēhē o ngā mahi o ngā ākonga

Me pēhea e mōhiotia ai te motuhēhē o ngā mahi a ngā ākonga? He tukanga, he taunakitanga me whai, e mōhiotia ai nā te ākonga ake āna mahi aromatawai. Kia mataara ngā ākonga, ngā kaiako me te whānau hoki o te kura ki te motuhēhē o ngā mahi a ngā ākonga.

He māmā noa iho te tiki mahi a tangata kē, heoi, mā te mihi e whakaatu, e whakanui hoki i ngā tātanga me ngā puna awhina i puta ai ngā mahi a ngā ākonga.

Hei tauira:

- He rerenga kupu poto e tohu ana i te pūtakenga mai o tētahi kōrero;
- He rārangi tohutoro i te whārangi whakamutunga o ngā mahi;
- He mihi ki ngā puna āwhina, ki ngā puna kōrero;
- Ngā momo puna āwhina, puna kōrero rānei:
 - » he kōrero ā-waha: he uiui i ngā kaumātua, i ngā pakeke, i ngā rangatira, i ngā mātanga rānei;
 - » ngā pukapuka i whakaputaina;
 - » ngā pukapuka kāore anō i whakaputaina;
 - » ngā wāhitau ipurangi, ngā honongaitua rānei.
