Ngā kiriata Tūmomo Atu:

- Hula Hawaii Mark Keali'i - Ho'omalulu (2024)
- Shiva Shambho - Bharatabatyam Dance (2018)

Te Aromatawai: *Kōwhiringia ngā hūanga e TORU hei whakaoti i ngā wāhanga e rua o tēnei tūmahi.*

- a. Mai i ngā hūanga e RUA kua kōwhiria e koe, kōrerohia ngā ritenga me ngā rerekētanga o TĒTAHI o ngā kiriata o Te Ao Haka, me TĒTAHI o ngā kiriata o ao kē atu. Whakamāramatia te whakamahinga o aua hūanga ka whāia e koe hei whakaniko ake i ngā kiriata e RUA.

- e. Te huānga whakamutunga i kōwhiringia e koe, kōrerotia ai te pānga o ngā ritenga me ngā rerekētanga i kitea ana i ngā whakaaturanga e rua. Hei tauira,
- Te whai pānga o te whakaaturanga ki a koe, ki tō whatumanawa i a koe e mātaki ana.
 - Te mau ki te tikanga, ki te ia hoki o te whakaaturanga mā ngā huānga nei.
 - Ngā āhuatanga whakaniko, whakarākei i te whakaaturanga.

Te Tirohanga:

Ko te aronga matua kia tautohua, kia āta tātari hoki i ngā ritenga me ngā rerekētanga o ngā huānga Te Ao Haka. E hāngai pū ana tēnei whakaaro nui ki ngā tikanga o Te Paerewa 91982, ko te paearu paetae (A, M, E) e mārakerake ana te kite, te whai māramatanga anō hoki ki ngā tikanga o te aromatawai. He whakaaro i te mea tēnei TAPA ka noho te paearu paetae hei E, M, A – He kōrero ōhiti i te mea ahakoa te painga o te aronga atu ki te Kairangi, kia kua rā hoki e wareware ki ngā whakaakoranga matua hei puhitaioreore.

Pūrongo Paerewa Paetae:

Ko ngā Ākonga i eke ki te **Kairangi** i te paerewa paetae nei:

- i whakamana, i whakatairite ai ngā rerekētanga/ōritenga ki tōna whakaawenga mai i ngā huānga o ia whakaaturanga.
- i hāpai, i āta whiriwhiri i te taunakitanga hei urupare mai i ngā whakaaturanga e rua, ā, he marutuna/maruwehi te taha huritao o taua taunakitanga.

Ko ngā Ākonga i eke ki te **Kaiaka** i te paerewa paetae nei:

- i whakamāramahia ngā huānga, ā, i whakatairite hoki i ngā whakaaturanga.
- i hāpai i ngā urupare mai i ngā taunakitanga o ngā whakaaturanga.

Ko ngā Ākonga i eke ki te **Paetae** i te paerewa paetae nei:

- i pai te whakamāramatanga mo ngā huānga e toru, te whakapuaki mai hoki o ēnā ki roto i ngā whakaaturanga.
- i mahue mai ngā rauemi hāpai hei urupare i ngā whakaaturanga.

Ko ngā Ākonga **Kāore i whiwhi** i te paerewa paetae nei:

- kāre he whakamāramatanga, he whakapuaki mo ngā huānga e toru, me ngā whakaaturanga.
- kāre i āta tohu i ngā rerekētanga me ngā ōritenga.
- kāre he taunakitanga hei rauemi hāpai i ngā urupare.

It is crucial to adequately prepare candidates prior to the External Assessment Date. Candidates' readiness for the Common Assessment Activity relies on sufficient time to practice and deliberate.

Section 2: Report on the standards

91982: Compare a Te Ao Haka performance and one other performance.

The External Assessment:

Context – Te Ao Haka performances and two other performances.

Choose ONE of the two Te Ao Haka performances and ONE of the two other performances and use them to answer all parts of the assessment.

Te Ao Haka Material:

- Mōtai Tangata Rau - Te Whakaeke, Te Matatini (2019)
- Tū Te Manawa Maurea - Te Poi, Tamararo (2023)

Other Genre material:

- Hula Hawaii Mark Keali'i - Ho'omalū (2024)
- Shiva Shambho - Bharatabatyam Dance (2018)

The Assessment: *Choose any THREE elements to answer both parts of the task.*

- Using the TWO elements selected, discuss the similarities and differences between ONE of the Te Ao Haka kiriata and ONE other genre kiriata. Also explain how you would have utilised these elements to further enhance the TWO kiriata.

(e) Using the remaining (ONE) element chosen, discuss the impact of similarities and differences they share in the two performances, e.g.:

- Affected how you felt when watching the performances.
- Helped communicate the messages in the performances.
- Enhanced the performances.

Observations:

The primary purpose is to identify and analyse the similarity and differences of the Te Ao Haka elements. This activity is specifically aligned with the requirements of standard 91982, The sequencing of criteria (A, M, E) provides clarity, enabling understandability of progression/step ups required. Noted as the current layout of TAPA is E, M, A – a reminder for Kaiako to obviously glance at excellence, however, don't forget to scaffold.

Report on the Achievement Standard:

Ākonga who were awarded Achievement with **Excellence** commonly:

- demonstrated a thorough and nuanced analysis by examining the similarities and differences of the selected elements from both performances, and how these impact the overall presentation.
- responses were substantiated with carefully selected and relevant evidence drawn from both performances, reflecting a sophisticated level of critical engagement.

Candidates who were awarded Achievement with **Merit** commonly:

- demonstrated a clear understanding of the elements, making meaningful comparisons between the performances.
- responses were supported with relevant evidence drawn from the performances.

Candidates who were awarded **Achievement** commonly:

- responses demonstrated a basic identification of similarities and differences.
- to progress further, ākonga need to strengthen their responses by supporting their observations with specific references to the performances.

Candidates who were awarded **Not Achieved** commonly:

- didn't describe three elements or explain how these were expressed in both performances.
- responses lacked even a basic identification of similarities and differences.
- didn't provide supporting evidence to justify their observations.
