2 Definitions

Actual examples of concepts of justice may include:

- for the concept of balancing competing claims name suppression; law of defamation;
- for the concept of impartiality judge and jury system; inadmissibility of evidence of prior convictions;
- for the concept of equity judicial discretion at sentencing; relationship property division;

• for the concept of coercive power – the death penalty; contempt of court. *Case law* refers to the collection of past legal decisions written by courts and similar tribunals in the course of deciding cases, in which the law was analysed using these cases to resolve ambiguities for deciding current cases. These past decisions are called "case law", or precedent.

News media refers to factual reporting and journalistic narratives in print media, broadcast media and the Internet.
